We will look at the most popular stories of Medicare tactics and requirements; and find out which ones are true, and which ones are myths. Through it all, we'll discuss how you can protect yourself from falling prey to the myths that can cause claim denials. The most discouraging and frightening stories involve the documents in the SUPPLIERS CONTROL. This session will focus in on the common documentation mistakes suppliers make to their own records by following the myths (instead of the facts), and how to protect yourself from self-inflicted wounds.

 Do you really know how to do a review of your patient files against Medicare guidelines? You've listened to webinars discussing the coverage policies and think you understand what is required in the documentation, but have you ever tested your knowledge?  CGS has been awarded the Jurisdiction B DME MAC contract by CMS representing approximately 20% of the national DME processing workload. The contract transition from NGS to CGS has been underway for weeks and we're pleased to have representatives from the new contractor, CGS Administrators, to provide the latest information be on-hand to answer questions just days before the switch.
